


Biometrics

How It Works

- Businesses capture images of their documents, and Valify swiftly extracts and organizes the data within seconds.
- After this, our Transliteration service can be added as a following step to transliterate the extracted data from Arabic to English.
- Validation: We are working to integrate capabilities that will soon validate the extracted data from the Commercial Register and Tax ID, thereby preventing potential fraud or manipulation.
